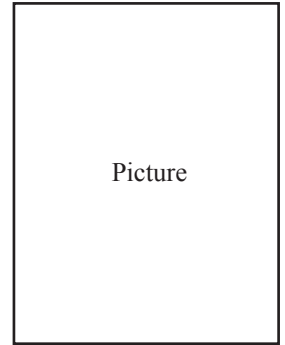

# GET MEMBER CHARTA

The First International Free Chapter a.s.b.l supports onto the statutes of the Chapter, it is not tied to an official Harley-Davidson dealer how it is defined in the HOG Charta.

That First International Free Chapter a.s.b.l profits through that not of opposite this status to the HOG and does not need to stick through that to the recommendations of the HOG.

The objective of the First International Free Chapter a.s.b.l is to lead it together Harley & Buell rider, ride together, to make friendships and to help oneself under each other. The web page of the Chapter should all to give members the possibility of various information.

The Chapter Office puts itself together as follows:

one DIRECTOR, one ASSISTANT-DIRECTOR,  
one SECRETARY, one TREASURER.

The Chapter Office is not elected.

In get member of the First International Free Chapter a.s.b.l you must be a member of HOG, to have the recommendation of a godfather, must make a trial period as a guest member and the approval of the OFFICE (Vote), and to declare to respect and recognize the Chapter charter and they members.

In order as a full member one must be valid: To be owners a Harley-Davidson or Buell motorcycle, to be in possession of a valid HOG number, and to have paid the annual membership fee.

Every First International Free Chapter a.s.b.l member is even responsible for be do and act.

That First International Free Chapter a.s.b.l sticks not for Person, matter-and property damages of any kind, as well as for other occurring troubles which the force majeure is of in charge.

The patch of the First International Free Chapter a.s.b.l put together from a HOG Patch (available at your local Harley Dealer) above that the name of the Chapter in the form of a banana stands, as well as a label's which one recognizes the native country of the member too gives. That wear the patch's is allowed only full members. That wear to that one patch is not compulsory, it becomes, however, in the case of events which ones are organized by the Chapter or wanted visited. Furthermore that is to attach from religious or political forbidden to motivated signs next to the signs First International Free Chapter a.s.b.l.
